In terms of announcement made in Union Budget 2022-23 and directives of Railway Board, proposal was received from you for installation of temporary stall/kiosk at Ranchi station under '**One Station One Product**' pilot project to showcase your '**Bamboo and woven Artifacts**'. It is to inform you that your firm has been selected through draw of lot to promote and sell their '**Bamboo and woven artifacts**' through temporary stall under "**One Station One Product**" pilot project at Ranchi Railway station. The allotment shall be valid for a period of fifteen (15) days from 24.04.2022 to 08.05.2022 with following terms and conditions:-


1. You will be allowed to sell & Promote '**Bamboo and woven Artifacts**' only through Railway earmarked space i.e. in the Concourse area, the space vacant between exit gate and entry gate.
2. You shall be required to submit the list of number of staff engaged at stall to the station Manager for station permission. The staff should not be exceed more than 04 (four) in one shift.
3. You are permitted to do vending at platform area but vending is not permitted inside the coaches of train. No platform vending is permitted between 22:00 hrs. to 05:00 hrs.
4. The staff should wear a badge clearly indicating 'One station One Product'.
5. Temporary Kiosk/Stall is permitted only for 15 days starts from 24.04.2022 to 08.05.2022 under 'One Station One Product' scheme.
6. A token fee of Rs.1000/- shall require to be submitted to this office before commencement date i.e. on or before 24.04.2022.
7. Exhibition/selling will not hamper train operation and neither will it undermine safety of passengers and goodwill of Railways. An undertaking mentioning the same shall be

submitted to this office.

8. You shall required to report to Station Manager, Ranchi for all relevant assistance and he will be overall field in-charge of this pilot project. In addition to Station manager, following Commercial/Catering Inspectors are also available for assistance:-



9. You will not assign, sublet, or part with the whole or any portion of this license or in any way alienate your interest or benefits of this license. On any violation of this condition, this temporary allotment shall be immediately ceased.
10. You will have to observe the following conditions strictly:
- For exact determination of sale, proper billing should be issued.
 - Daily sale record will be maintained.
 - Proper inventory/ stock control system have to be maintained.
 - Share the sales details & feed back with Railway officials on daily basis.
11. You should ensure proper billing for the items sold in the unit and you should provide the facility for cashless transaction viz. POS/Swipe Machines, BHIM, Mobile Wallets, Bharat QR Code, any new scheme/tools/instruments introduced by Govt. of India or Ministry of Railways for promotion of cashless transaction etc. compulsorily available in the unit.
12. You will also ensure that the person employed in the sale of said articles shall be properly dressed with their identity cards clearly indicating name of the authorized vendor, product name and duration.
13. All taxes payable on account of the grant of license including sale tax/GST etc will be borne by you exclusively and the Railway will not be responsible towards the same at any time during the term. Furthermore, in the event that any new tax is imposed or an existing tax enhanced under a governing law upon the service then you will be permitted to collect the new/revised tax from the passenger, the liability of payment of tax to the government agency will be also borne by you exclusively.
14. In the event of arbitrator dying, neglecting or refusing to act or resigning or being unable to act for any reasons or his reward being set aside by the Court for any reasons, it shall be lawful for the authority appointing the arbitrator to appoint any other arbitrator in place of the outgoing arbitrator in the manner aforesaid.
15. This allotment is purely provisional and Railway reserves the right to cancel the allotment without any prejudice.
16. If the above terms and conditions are agreeable, may please start work w.e.f. 24.04.2022. Please acknowledge the receipt.
